This is not a live fire training you will not be taught how to shoot a firearm.

This class does have an exam and practical exercise that will need to be completed prior to receiving certificate

OBJECTIVES OF THE COURSE WILL INCLUDE

WI. D.O.J PROCESS FOR OBTAINING, MAINTAINING, AND RENEWING A CCW PERMIT.
ACCEPT RESPONSIBILITY FOR YOUR FIREARM IN THE HOME AND IN PUBLIC.
ANALYZE CONSIDERATIONS REGARDING THE CARRY OF A CONCEALED WEAPON.
DISCUSS THE LEGAL IMPLICATIONS OF CARRYING A CONCEALED WEAPON.

COST OF THE COURSE WILL BE \$50.00

By taking this class it will not permit you to carry concealed until you have your Wisconsin Concealed Carry License. You will be asked to leave the classroom with no refunds if you are involved in any horseplay or unsafe acts that have a cause or potential to cause injury.
