REPORT DATES/TIMES

Sentenced inmates will be accepted into the jail on Thursdays (9:00 a.m.) and Saturdays (7:00 p.m.). If you fail to report by the date ordered by the court and determined by the jail, you may be criminally charged with "Failure to Report to Jail" and/or lose Good Time. You are not guaranteed the starting date you desire; the jail has final discretion for setting that date. Only the sentencing Judge may grant beginning date extensions, not the jail. You <u>must</u> contact the Jail at 920-746-5651 within 10 days of your sentencing date to schedule your starting date.

INCARCERATION FEES AND CHARGES

The Door County Jail assesses and collects out of your Inmate Trust Account the following fees and charges:

Processing Fee: \$ 30.00

Daily Fee: \$5.00 (plus tax) per day

Entry Kit Fee: \$5.00 (plus tax)

Transfer Fee: \$50.00

If serving an Ordinary sentence arising from a conviction in another county: \$52.00 (plus tax) per

day

*** OUTSTANDING JAIL DEBT IS THE RESPONSIBILITY OF THE DEFENDANT AND SHOULD BE PAID IN FULL PRIOR TO THE START OF THEIR COMMENCEMENT. ***

ADDITIONAL INFORMATION

- All inmates are expected to report to the jail sober and drug fee. If you test positive for alcohol or drugs, you will be placed in segregation for 5 days without privileges, and lose 2 days of good time if applicable.
- Inmates must bring in prescription medications in the original container and must be properly labeled. The prescription must have been filled within the previous 30 days. Inmates must turn in all medications to jail staff to be approved by the Health Services Unit prior to being dispensed.
- You will be issued an entry kit of basic hygiene items at the time of booking and weekly thereafter. Additional Hygiene items may be purchased through the commissary.
- Inmates may not bring in or receive reading material except by subscription or book store mail delivery. Hard covered books are **not** allowed in the jail.

VISITATION

Males: Thursday 6:00 p.m. – 9:00 p.m. **Females:** Saturday 6:00p.m. – 8:00p.m.

- Each inmate is allowed one thirty (30) minute visit per week. All visitors must be Pre-Approved prior to visitation.
- You may have a maximum of four visitors on your Pre-Approved list, plus your minor children. Two visitors per week will be allowed, plus your minor children.
- Former inmates of the Door County Jail will not be allowed to return to the Jail as a visitor until a period of thirty (30) days has elapsed since the inmate's release from the Jail.
- Pre-Approved visitors should call 920-746-5655 to have visitation scheduled.

The Door County Jail is a smoke-free facility. Possession of any tobacco products, lighters or matches is prohibited.
